Schedule

Saturday, October 3rd: Round 1, Tully Lake, 18 holes. Round 2, Barre Falls Dam, 18 holes

8:00 – Registration, Tully Dam

9:00 - Players Meeting (look for sign)

9:15 - Start Round One, Holes 1-18

Lunch (on your own, in transit)

1:15 pm - Round Two Players meeting, Barre Falls Dam (near picnic shelter)

1:30 pm – Round Two, Holes 1-18

Sunday, October 4th: Round 3, West Thompson Lake, 18 holes. Round 4, Buffumville Lake, 18 holes plus Safari round for top Pro and Advanced players.

8:30: Players Meeting, West Thompson Lake (near Tee #1 at boat ramp)

8:45: Start Round Three, Holes 1-18

Lunch (on your own, in transit)

1:00, Players meeting, Buffumville Lake (behind office)

1:15 pm - Start Round Four, Holes 1-18

4:00 - Safari Round - top players in Pro Open and Advanced will play a 5 or 6-hole safari round at Buffumville Lake.

5:30 – Cookout & Awards Ceremony (at Buffumville Lake)

Special Conditions: Use of illegal substances, and use of alcohol during play, is an automatic disqualification. Ace pot for each course; unclaimed ace pots go to the Dam Big One. Top scorers at each course win special prizes. Overall top professionals (40% of field) win cash. Overall top amateurs (45% of field) win Buffumville Bucks. Pre-tournament check-in by 9 am on Saturday required (even if pre-registered). 100% payout after expenses. All expenses pro-rated across divisions.

Directions:

To get to Tully Lake Disc Golf Course - In Massachusetts, take Route 2 to exit 17. Follow Route 32 North approximately 6 miles. From New Hampshire, follow Route 32 south about 8 miles from the intersection of Route 119 in Richmond. Route 32, also called Athol-Richmond Road, goes right over Tully Dam. Tee for Hole #1 is on the south side of the dam next to the inlet.

To get to Barre Falls Dam Disc Golf Course - From Gardner on Massachusetts Route 2, take Exit 23, Route 68. Travel south on Route 68 to Route 62, then two miles west to the dam. From Massachusetts Interstate 495, take 290 to 190 to the Holden Exit, Route 68. Take a left and follow Route 68 North until you come to Route 62. Take a left at the blinking light. Barre Falls Dam is approximately two miles down on the left. Tee for Hole #1 is next to picnic shelter on east end of dam.

To get to the West Thompson Disc Golf Course – From I-395 take Exit 99. Take Rte. 200 East to Thompson Center. At the red flashing light take a right onto Rte. 193. At the next traffic light go straight across Rte. 12. Cross the railroad tracks and go to the top of the hill. Turn right onto Reardon Rd. to go to the Park Office, Boat Launch, and Campground. Tee for Hole #1 is just past the gate near the entrance to the Boat Ramp area.

To get to Buffumville Lake Disc Golf Course - From Interstate 395, take Exit 4B Oxford center. The Buffumville Lake office is 48 Old Oxford Road (Buffums Dam Road) 2 1/2 miles from the Interstate. From the Massachusetts Turnpike, take the Sturbridge exit and follow Route 20 to Charlton. Take a right onto Route 31 and follow the signs to Buffumville Lake. Tee for Hole #1 is behind the public restroom and office complex.
